

Data Protection Statement

As the protection of your data is very important to us, we process the information that you leave behind upon visiting our website only in accordance with the provisions of the relevant regulations governing data protection, in particular those of the Federal Data Protection Act (Bundesdatenschutzgesetz; hereinafter: BDSG) and those of the Telemedia Act (Telemediengesetz). We therefore wish to inform you at this point of the type, scope and purpose of collecting and using personal data.

Upon commencement of employment, our employees are bound to maintain data secrecy pursuant to para. 5 BDSG. In addition, necessary technical and organisational measures have been taken to ensure the protection of your personal data.

Please note that this Data Protection Statement only relates to our website and does not cover third-party websites to which ENAiK00N refers by way of links.

Object of Protection

The object of protection is personal data. In accordance with para. 3(1) BDSG, personal data concerns details of personal or factual circumstances of an identified or identifiable natural person. Included hereunder is information by which you may be identified (e.g. information such as name, postal address, email address or telephone number).

Collection and Processing of Your Data

When you visit our websites, our web server saves the following standardised information, unless you object:

- the IP address issued to you by your internet service provider;
- the page of our website you visit;
- the web page from which you visit us;
- the date and duration of your visit;
- the name of the data accessed; and
- a description of the web browser used.

We use this data to optimise our website. The data is saved anonymously, with the result that you are not personally identifiable as a visitor.

We only save personal data if you voluntarily provide it, for example in order to perform a contract, or if you contact us via our contact form.

Use and Disclosure of Personal Data and Purpose of Use

We respect the principle of using data for specific purposes only. We thus collect, process and save your personal data only for the purpose for which you gave it to us. Personal data will not be disclosed to third parties. Personal data will only ever be disclosed:

- if you consent to the disclosure;
- if it is necessary for the conclusion, execution or termination of a contractual relationship with the person in question; or
- if we are obliged to disclose it by mandatory provisions of law or on foot of a court judgment.

ENAIKOOK ID

When you register for an ENAIKOOK ID, you will be asked for your name, email address as well as, optionally, your telephone number and company name. ENAIKOOK saves and uses this data only for the administration of user accounts and deletes it when the account is closed. ENAIKOOK will not use the data for other purposes.

Use of Cookies

We use so-called cookies at various locations on our web pages. These are small text files that are saved to your computer by your browser. Cookies serve in making our website more user friendly, more effective and safer. Cookies will not cause damage to your computer and do not contain viruses. Should you wish to view our websites without cookies, you may deactivate cookies at any time via the settings of your browser. In addition, existing cookies may be deleted. More information may be found in the help feature of your internet browser.

The web analytic tool used to provide statistical analysis of visits to the website <https://www.enaikoon.com> uses cookies. The text files saved on your computer allows us to analyse the use of the website. The information on the use of our website created by the cookies is saved on our servers. The IP address is made anonymous immediately during processing before it is saved. Individual users are not identified. The identity of visitors always remains protected.

Facebook Social Plugins

Our website utilizes social plugins from Facebook Inc. (1601 South California Avenue, Palo Alto, CAL 94304, USA) on our websites. A list of the possible Facebook plugins and what they look like can be found here: <http://developers.facebook.com/plugins>. When you connect to one of our websites where a Facebook plugin is integrated, a direct connection with a server of Facebook Inc. is established. The code from Facebook is retrieved even if the “like” button has not been selected. Along with other information, your browser sends the URL of other currently open webpages to Facebook. If you are logged into Facebook, the session-ID can be used to assign the currently open browsers to your profile. When you use the “like” button or the comment function, this information is transmitted to and saved by Facebook. Even if you don’t have a Facebook account, it may be possible that Facebook is collecting this information. Your browser may contain a cookie whereby when you later decide to register an account on Facebook, the information collected by Facebook is assigned to this new account. We explicitly point out that we have no knowledge of the content or scope of the transmitted and stored data collected by Facebook and therefore refer to the current privacy policy of Facebook: <http://www.facebook.com/policy.php>.

When visiting our pages where a Twitter plugin is integrated, your browser establishes a direct connection to the servers of Twitter. In doing so, the content of the plugin from Twitter is transferred to your browser and then embedded into the content of our website.

Through the use of the plugin, information that you have visited our website is sent to Twitter. This information is also attributed to your Twitter account. Please note that by using the Twitter button, information is transmitted directly to Twitter and probably saved. We have no ability to influence what data is transmitted or saved.

Google +1 Button

Our websites utilize the Google +1 Button “+1 Button” of Google Inc. (1600 Amphitheatre Parkway, Mountain View, CA, 94043, USA). By visiting our websites, a connection with the servers of Google Inc. is established. The content of the Google +1 button is sent and integrated on your browser and in doing so informing Google that you have connected to our website. According to Google, the data that is collected from your visit is for system maintenance and problem solving purposes. We have no real knowledge or influence about the scope and nature of the data that Google collects. Google also openly records further data about your Google +1 activities. If you have a Google account, a Google Plus membership and are currently logged in to these services, when you click the +1 Button, your IP address, the webpage visited and the content of what you have activated will be saved by Google. According to Google, this data can be used with your profile name, your photos, on what content you have activated the +1 button, in other Google services, your Google profile and other locations.
